

Tuesday, September 19, 2023

At the regular monthly meeting of the Mt. Gretna Campmeeting Association Board of Managers, held on Tuesday evening, September 19, 2023, in person at the Mt. Gretna United Methodist Church and via Zoom Webinar, Pat Wilmsen presided.

1) Call to Order, Pat Wilmsen

The President called the meeting to order at 6:30 p.m. Pat Wilmsen conducted the roll call.

A quorum was present including the following: (in person) Miles Bojanic, Joe Lamont, George Leyh, Ted Martin, Esther Mefferd, Jeff Minnich, Kevin Wells, Pat Wilmsen, (and via Zoom) Kevin Burd. Marcie Lloyd was excused.

2) Board Resignations & Appointments

The Board recognized the resignation of Don Dale, effective September 01, 2023, submitted due to the sale of his Mount Gretna Campmeeting property.

Ann Bering had been elected to take Don Dale's seat in the 2023 election. Joe Lamont made a motion to bring Ann Bering on to the MGCA Board of Managers effective 9/19/2023. The motion was seconded by Esther Mefferd and passed with Bojanic, Burd, Lamont, Leyh, Martin, Mefferd, Minnich, and Wells voting in favor. **Resolution #2023.09.19-01**

3) Approval of Minutes

- (a) Since the Minutes of the August Board meeting were distributed to Board members prior to the time of this regular monthly meeting, the reading of the Minutes was dispensed with and the August 15, 2023 minutes were approved on a motion by Jeff Minnich. - (b) Since the Minutes of the 2023 Annual Meeting of the Board of Managers were distributed to Board members prior to the time of this regular monthly meeting, the reading of the Minutes was dispensed with and the July 29, 2023 minutes were approved on a motion by Ted Martin. The motion was seconded by Miles Bojanic and passed with Bojanic, Burd, Lamont, Leyh, Martin, Mefferd, Minnich, and Wells voting in favor.
